2. Proposed by Mr G Henwood, seconded by Mrs R Hore, all agreed to approve & sign the following cheques:
  - £1000.00 N Trebilcock – Defibrillator for Little Petherick Village Hall
  - £66.60 HMRC – tax on clerks salary for February
  - £266.74 J Wilson – clerk's salary for January
  - £58.71 J Wilson – clerk's expenses for January
3. Chair will meet solicitor to check through Lightsource agreement after this month's meeting.
4. Request from St Breock Parish to ask that St Issey Parish allow St Breock half of the £10,000 allocated to St Issey from Lightsource. Mr P Hammett proposed and Mr G Henwood seconded to retain the £10,000. Majority in favour. Clerk to write to Mr Jarrett and Mr Springett informing them of the Parish Council's decision.
5. Trenouth Solar Farm Panel – Applications can still be received, although the panel has been disbanded.
6. Mr D Heard wind turbine: Constitution required, also check on whether this need to be registered with the charities commission.

### **The St Issey Men's Institute**

The Councillors met this evening at 7pm at the Institute in order to look into what might be done to get more use out of it.
